### **GUIDANCE COUNSELOR UPDATE**

Diane St. Amand

- Students have come back to school after COVID-19 closures with quite a bit more anxiety, depression, suicidal ideations, self-harm, and behavioral concerns. There have been more DCS calls and more referrals to the crisis response center. Diane has had a huge increase of parents seeking her help and 504 plan requests.
- We have systems in place to help support and guide families as well as staff.
- Diane is developing some mental health support groups. Champion Check-in is a good place for students to have a voice and be heard. This information funnels to Diane from the teachers.
- The Attorney General's office sent someone to speak to the staff about suicide prevention. They will be back next semester to speak to students and parents.
- NAMI has also come to speak to the students, and will present to parent tomorrow, October 6<sup>th</sup>.

- The “Be Unique” program is back, helping to build healthy relationships, good decision making, goal setting, effective communication skills, refusal skills, etc.
- We have been able to offer 32 different guidance lessons amongst groups this 1<sup>st</sup> quarter, including True Colors, Fair is not always equal, A great classmate is, 4 part apology, Is it rude, mean or bullying?, and Friendships.
- Our Courageous Bystander program allows Diane to count on students reporting what she doesn’t see. It encourages students to report serious behaviors such as bullying, cutting, suicidal ideations, drugs, weapons, tobacco, etc.
- We have partnered with the Optimist Club for 4<sup>th</sup>-8<sup>th</sup> grade students, recognizing outstanding student achievement at the end of each quarter.
- Lunch Bunch Friendship groups will start to meet once the weather improves a bit.
- Diane seeks out help when she needs it and can turn to our Seal team. She recognizes that Tucson Country Day School has enough students to warrant a second Guidance Counselor on staff.

## **ADMINISTRATION UPDATE**

Jordan Krause AND Terra Maddock

- Jordan will have Denise Fiore prepare an update regarding the Literacy Program for the next board meeting.
- Our first Champion Showcase was last Friday, October 1<sup>st</sup>. A survey will be going out to get some feedback from families that attended. The quarter 2 showcase will have more projects run through the PBL planning components outlined in “Keep It Real with PBL: A Practical Guide for Planning Project Based Learning.”
- 2021 AzM2 Testing takeaways: Writing and language development will be an ongoing school-wide focus area. Mathematically, grades 3-6 will emphasize algebraic thinking and numbers in base ten. In grades 7 and 8 a focus on the Number System will be given extra emphasis this year.
- The Professional Development plan for quarter 2 will start with all staff designing their own Professional Growth Plan (PGP) throughout the second quarter under the guidance of their Growth Coach. The PGP seeks to move away from the one-size-fits-all traditional model of evaluation by incorporating the TCDS Core Values and empowering staff to design their own learning goals within the boundaries of these Core Values. A video tutorial outlining the components of the PGP will be shared with all staff members the week of October 18<sup>th</sup>.

    - Wanda McDonnell- Lil Champs staff (Preschool through 1<sup>st</sup> grade)
    - Terra Maddock- 2<sup>nd</sup> through 5<sup>th</sup> grade teachers and specialists
    - Jordan Krause- 6<sup>th</sup> through 8<sup>th</sup> grade teachers, SEAL Team, Admin and Business Office staff, Student services staff and the Leadership Team
    - Kelly Grusendorf- Resource teachers and Paraprofessionals
- SEAL Team update: The team is currently developing and refining schedules that make time for guiding and supporting teachers as they support students, as well as working directly with students. Student Information Profiles, diagnostic testing

data and teacher observations drive decisions about which students will be receiving on-on-one or small group services.
